5. Terms of Collaboration

a. Artistic Boundaries & Conduct

- The model does not agree to any erotic, pornographic, fetish, or explicit content.
- No open-leg poses, orgasm faces, visible labia, or sneaky/voyeuristic images.
- The model only shoots within the genres of beauty, artistic, and tasteful nude photography. All content must align with a respectful, artistic vision.
- No changing-room photos or filming without consent.
- No group shoots or press-conference-style multi-camera setups.
- No physical contact for pose direction.
- All shoots must take place in private or secure environments.
- Breaks of 5 minutes per hour are required.
- The photographer agrees to send a minimum of 5 edited images within 3 months to model.

b. Usage Rights - Photographer

- Photographer retains copyright of all images and may use them for:
 - Portfolio, website, print, and social media with credit
 - Magazine submissions, competitions, and exhibitions
 - Commercial usage is only permitted if the commercial add-on is purchased.
 - Video usage is only permitted if the Video add-on is purchased.
 - No content may be used for adult, erotic, subscription-based, adult-oriented or illegal platforms.
 - The model's artist name "Naked Soul" will be used in all credits and promotional mentions. The model's real name or legal name will not be used without written permission.
 - No visible nipples or labia posted on social media or public platforms like YouTube. (even if blurred)
 - Any images with unintended exposure (genitals/labia) must be deleted.

c. Usage Rights - Model

- Model may use provided images for portfolio, social media, website, and promotional purposes.
- Model may include images in professional and personal projects (e.g., books, documentaries), where images support but are not the primary subject, No additional licensing fee shall apply.
- Model may create and use behind-the-scenes content captured on her device commercially.

d. Communication & Shoot Timing

- All communication and confirmations must be in writing.
- Shoot officially starts 10 minutes after model's arrival.
- Delay by photographer may incur additional charges.
- Ending early does not reduce the fee.

e. Cancellation Policy

- Deposit is refundable only if cancelled 15+ days before shoot.
- Cancellation within 15 days allows reschedule but no refund.
- Cancellation within 48 hours or same day requires 100% of fee.
- If model cancels, deposit is refunded in full.

f. Remote Shoots (If Applicable)

- No screen recordings or screenshots are allowed.
- Model reserves the right to remove any overly revealing images.

g. Workshops / Group Shoots

- Model does not shoot in environments with multiple simultaneous photographers.
- Organizer must ensure all attendees are informed of these terms in advance.
- Model is not responsible for lack of communication among attendees.

h. Dispute Resolution

- All issues will be resolved with mutual respect and clear communication.
- Any unresolved legal matters will fall under the jurisdiction of Dutch civil law.

6. Final Declaration

By signing this agreement, both parties confirm that they understand and agree to all terms stated above. This agreement is legally binding and must be signed before the start of the session.
